

VICINITY MEDIA PADEL LEAGUE (VMPL) JOHANNESBURG COMPETITION TERMS & CONDITIONS

- This competition starts on 8 May 2025 and ends on 3 July 2025.
- Teams who want to enter the VMPL have to complete the VMPL entry form before 25 May 2025.
- Not all teams who enter will be selected to participate in the VMPL.
- An internal Vicinity Media panel will evaluate all the entries and will select and announce the final participating teams before 8 May 2025.
- Final teams will be added on a WhatsApp Group where all the match info and leaderboard updates will be shared. Teams need to ensure that their team members are added to the group.
- Ten teams will play a 60 minute game of padel against each other at Next Gen Padel, Bryanston on the following dates: 8 May 2025, 15 May 2025, 22 May 2025, 29 May 2025, 5 June 2025, 12 June 2025, 19 June 2025 and 3 July 2025.
- Each team has to play on all of the above mentioned dates and have to ensure that they are on time for each match as court time has been pre-booked.
- If one of the players is not available then the replacement/3rd player has to fill their place.
- If both players are not available then the replacement/3rd player as well as a 4th player has to fill their place.
- Teams that fail to show up will be disqualified automatically.
- Points are allocated based on sets won. One point is allocated to the team who wins the most sets in each match.
- Each team has to ensure that they are present when their scores are logged and that they agree with the scores that are being submitted.
- The team with the most points at the end of the league will win the grand prize.
- The winning team will win an all expenses paid trip to Cape Town to play against the winners of the VMPL Cape Town League.
- Expenses covered are at the discretion of Vicinity Media and will be communicated to the winners.
- The grand prize winners will be announced on 3 July 2025.
- The winners will receive a revolving VMPL trophy which they will have to return to Vicinity Media prior to the match between the Cape Town and Johannesburg VMPL winners.
- By entering this competition, participants give consent to being mentioned and tagged on Vicinity Media's social media platforms. Any photos shared by the participants with Vicinity Media (i.e. receiving competition prizes etc.) will also be shared on Vicinity Media's social media pages.
